## "Prevent" Action Plan



Both New Road and Park Lane Primary and Nursery Schools recognise that they have a duty under Section 26 of the Counter- Terrorism and Security Act, 2015, in the exercise of its functions, to have due regard to the need to prevent people from being drawn into terrorism.

Equip staff to identify children at risk of being drawn into terrorism and to challenge extremist ideas.	Assess the training needs of staff in the light of the school's assessment of the risk to pupils at the school of being drawn into terrorism.	The designated safeguarding lead undertakes Prevent Awareness Training. Ensure that pupils have a "safe environment" in which to discuss "controversial issues".
